## FOUR COUNTIES MATCH

### Format

The competition is a Stableford 4-ball better ball played off full handicap with a maximum of 18 handicap. Each county selects a team of 6 pairs. The points from the best 5 cards are added together and the county with the highest points wins the event.

In the event of a tie the 6<sup>th</sup> card will count.

## SUMMER MEETING

### Format

This event is a team inter-club competition for teams of 4 players who represent their club in a Stableford format. A team provided by Club Reps will also participate but will not win the Trophy. The three best scores are recorded with  $\frac{3}{4}$  of handicap for each player up to a maximum stroke allowance of 18. If there is a tie, the fourth card is to count. The competition is played off the yellow tees.

This year's event is to be held at Marlborough GC on Tue 22 June 2010. Usual administrative arrangements will apply, with a single tee reservation for the 15 four-ball matches from 12.00 until 2.00pm.

**The cost of entry is £120 per 4-man team.**

The matches will be preceded by a light lunch from 11.00am and followed by a dinner from 5.00pm. The dinner will be in the form of a running buffet. Players should eat immediately after changing and not wait until everyone has finished the competition.

A Prize giving will take place about 6.30pm

There are no guests, no speeches and little formality

**Members who wish to be considered for selection should bid for a team place through their Club Representative.** It was recommended that for this event, the current Club Captain in each club should lead the team selected by ballot from those who wish to play. The team of 4 players with reserves should be nominated and received by the Meetings Secretary together with the **entry fee of £120** by Thu **13 May 2010**.
